 January 6th- activated to serve a "High Risk" drug warrant on a subject in Lansdale Borough. The warrant service was successful and a large amount of drugs were seized.

ACTIVITIES DURING 2007

- 1. During the month of May, the team trained with representatives from Trident Concepts of Texas. The team learned new methods on entries, room clearing, and stress shooting.
- 2. On November 11th, the team participated in the 1st annual Montgomery County S.W.A.T. Challenge that was sponsored by the District Attorney's Office. It was held at the new Montgomery County Tactical Response Training Center in Plymouth Township. The team tied for third place out of the eleven teams that participated. The events included two obstacle courses, hostage rescue (a live fire exercise), and a sniper course. Officer Kranich participated in the sniper course. He and his partner finished the sniper course with the best overall time.
- 3. From December 3rd thru December 6th, Officer Kranich attended a Less Lethal training school in Manheim, PA. The school was hosted by Combined Tactical Systems. Officer Kranich was certified as an instructor in the use of distraction devices, 40mm launcher, and in pepper spray.

ANNUAL REPORT FOR 2007

The Highway Safety Unit (HSU) was created in 2006. The officers of this unit specialize in the areas of traffic enforcement, motor carrier safety, and traffic accident reconstruction. Along with the other members of the police department, the officers of the HSU strive to ensure safety on the township's roadways. For 2007, the Franconia Township Police Department had over 3000 traffic related public contacts.

MOTOR CARRIER VEHICLE SAFETY INSPECTIONS----

 For 2007, there were 36 Motor Carrier Vehicle Safety Inspections consisting of:

32 North American Standard Safety Inspections (Level 1)*

4 "Walk-around" Safety Inspections (Level 2)

• Of the **36** that were inspected:

10 Motor Carrier Vehicles were placed Out-Of-Service per the criteria established by the *Commercial Vehicle Safety Alliance*. These vehicles were too hazardous to be driven and were removed from the roadway.

1 Driver was placed Out-Of-Service for operating a Commercial Vehicle without a driver's license.

 Total Number of Violations of the Federal Motor Carrier Safety Regulations:

Of the 36 inspections conducted in 2007, there were a total of **124** violations reported.

^{*} A Level 1 inspection includes brake measurements and an inspection of components underneath the vehicle.

ACCIDENT INVESTIGATIONS------

Officers of the police department responded to a total of **293** traffic accidents for 2007. Of those accidents:

- **142** were **REPORTABLE ACCIDENTS** where one or more vehicles needed to be towed, or injury was involved.
- 151 were NON-REPORTABLE ACCIDENTS where there were no injuries and the vehicles did not have damage to the extent towing was necessary.

OTHER TRAFFIC SAFETY INFORMATION------


- Officer Al Gesullo attended an accident reconstruction refresher course.




Complaints 5 Year Comparison




Communications 5 Year Comparison




Vehicle Crashes 5 Year Comparison

HIGHLIGHTS OF POLICE DEPARTMENT ACTIVITIES FOR 2007

- 1. Chief Joseph Kozeniewski, Sergeant Jeffery Gower, and Detective George Moyer attended the three-day training on Street Survival. The course presents intense training on continuing officer safety practices.
- Every sworn member of the department participated in a one-day Rapid Response training. The
 officers actively participated in confronting one or more armed subjects inside a school building
 with simulated ammunition. The purpose of this training is for first-responding officers to move
 towards stopping a shooter in a school or business due to the delayed time for a tactical team to
 respond.
- 3. In this light, we also conduct unannounced "lockdowns" of the four district schools in the township during school hours. This helps the students, teachers, and staff to practice moving to safety in the event that a dangerous intruder would enter the school.
- 4. The police department continues its relationship with the Souderton Area School District with regular meetings among the area Juvenile Officers. Additionally, quarterly meetings are held with the district staff on school safety.
- 5. Officers Dave Klepfer and Tim Boyle held their annual graduation exercise for over 200 elementary school students who graduated from the Drug Abuse Resistance Education program.
- 6. Corporal Ed Hall provided continuing education on the Pennsylvania Vehicle Code for the school bus drivers at Transportation Services, Inc.
- 7. Officer Glenn Kranich continued his monthly training as a member of the North Penn Area Tactical Response Team. Officer Kranich was also certified as an instructor in the use of the Taser device.
- 8. All officers in the department participated in their semi-annual firearms qualifications during 2007. The second training was held at the new Montgomery County Tactical Response Center which is a state-of-the art indoor police firearms facility in Plymouth Township. Officer Travis Bivighouse and Corporal Hall are the department's firearms instructors.
- 9. The department took delivery of a new 2007 Chevrolet Tahoe for patrol use.
- 10. Officer Albert Gesullo renewed his certifications for On-Scene Crash Investigation and Reconstruction.
- 11. Corporal Steve Rinker, as head of the Traffic Safety Unit, initiated a motor vehicle carrier safety initiative during 2007.
- 12. The police department welcomed many residents and visitors to the Franconia Community Park on August 11th to meet their neighbors and the police for the eleventh annual National Night Out Against Crime Celebration. Officer Tim Boyle coordinates the programs for this night.
- 13. Every officer attended their annual Municipal Police Officers Training & Education Commission update classes during the year.
