**NO POSTING** – The Franconia Township Police Department would like to remind residents that it is illegal to post anything on street signs, poles, and private properties. **NOTICE** – Any illicit discharge as defined in the Franconia Township Stormwater Ordinance is a violation of the code, and those who dump will be guilty of a misdemeanor and subject to a fine. 🌿

## Franconia Sewer Authority Update

Two major wastewater projects are nearing completion. The new treatment plant located between Souder Road and the Skippack Creek should be fully operational in November 2010. This facility provides treatment for the Souderton Area School District High School located on Lower Road. It will also be able to provide service (in the future) to what the Township has identified as the Lower Skippack Sewer District. This will include properties located along portions of Halteman, Lower, Schoolhouse, Moyer, Souder, Forman, Delp, Meetinghouse, Kulp, and Hagey Roads. The specific properties to be eventually served will be outlined in a Component 3M submission (Pennsylvania Department of Environmental Protection) that is used to modify the Township's 537 Plan (a document identifying sewer service availability and future growth areas). Once all of the portions of the Component 3M are complete it will be available for public inspection and comment (a notice will be put in the local newspaper).

The second major project nearing completion is the Earlington Sewer District. The final piece in this project is a pump station to be located on Allentown Road near Green Hill Road and the Branch Creek. This pump station will provide public sewer service to portions of Allentown, Sunset, and Rising Sun Roads. The pump station will also provide service to Salford Township residents in the Tylersport area. Anticipated completion is scheduled for October 2010.

Other smaller projects that the Authority will be working on (along with the above) is a small segment of sewers on Godshall Road near Reliance (schedule to complete this year), and Leslie Lane (scheduled for next year). 

## 2010 Leaf Collection Program


Franconia Township will be continuing the leaf collection program again this year. The service will be provided by BFI Waste Services of PA LLC this year.

- 1) Leaves must be placed in the biodegradable paper leaf bags. Plastic bags will not be accepted. Free Leaf bags can be obtained at the Township Building located at 671 Allentown Road, Franconia PA. The bags are available to Franconia Township residents only!! The office is opened Monday through Friday from 8:00AM until 4:30PM.
- 2) The bags must only contain leaves. Other household refuse or yard waste cannot be intermixed with the leaves. Bags containing items other than leaves will not be picked up by the hauler.
- 3) Place the leaf bags at the curb or street side where normal trash is picked up. The leaf bags and leaves will be picked up. The bags will not be dumped and returned.

Additional yard waste can be dropped off at the Barnside Farm


Compost Facility. You must call to arrange a drop-off. The facility is located on Haldeman Road in Lower Salford Township. Please call 610-888-7719 for more information. ## Use & Occupancy Permits

The Franconia Township Board of Supervisors is considering a pending ordinance pertaining to a new requirement for use and occupancy permits (U&O's) for residential re-sales in the Township. Currently, the Township requires U&O's for new construction and any commercial structures but not for the sale of existing homes. That may change later this year. The purpose of such an ordinance is to allow for the inspection of each structure and property for safety and zoning compliance. The proposed ordinance addresses (among many other items) verification of zoning conformance for sheds, decks, pools, and other accessory structures, confirms that dwelling units are in fair, habitable and useable condition and are free from any building code violations, and that sump pumps/basement drains are not discharging into the sanitary sewer system. In addition, the ordinance addresses a number of various safety items associated with a residential dwelling such as the presence of smoke detectors, fire separation walls in twins and row homes, and required railings on stairs, porches and decks, etc.

If the ordinance is adopted, anyone selling a home or their representative will be responsible to complete and submit an application for a U&O permit. Upon the satisfactory inspection(s) of the property, the building inspector will issue a permit. The fee proposed for this process is \$200. The ordinance is currently available for public review at the Township Office located at 671 Allentown Road. The office is opened Monday through Friday from 8:00AM until 4:30PM. 

## West Broad Walking Trail Completed

The Township recently added a new walking trail to the Township's trail network. This important piece of the network links the Harrington Village Trail and Open Space area to West Broad Street through the West Broad Elementary School Property. The 8-foot wide paved trail that is .55 miles long begins at the pedestrian bridge located along the perimeter of the Harrington Village Development. It comes across Township Open Space and then meanders along the property line of the West Broad Elementary School. The trail transitions into a natural trail through the woods near the S.A.V.E. House and then transitions back into a paved trail terminating at West Broad Street where the existing sidewalk takes over.

The successful completion of the trail is a result of hard-work and cooperation on behalf of Franconia Township,

the Souderton Area School District, and the surrounding neighbors. The various entities worked together to determine the proper alignment of the trail, the appropriate buffering and trail materials, the terms pertaining to its maintenance, and the actual construction of the trail. An

easement agreement was reached between the Township and School District in late June of 2010. The Franconia Township Public Works Department began working on the trail shortly thereafter. The trail was completed in August 2010. 🌸

## Recycling Information

Curbside recycling is mandatory in Franconia Township so all waste haulers operating within our township must offer this service. Recycle bins are available for township residents for free at the administrative office located on Allentown Road.

Additional Recycling: Additional recycling can be done at Franconia Township Highway Maintenance Department located at 480 Indian Creek Road. There are two comingled dumpsters for glass, plastic beverage containers #1 and #2, metal and aluminum cans. Cardboard may be placed in the third dumpster. Please crush boxes, etc. before placing in the dumpster.

In conjunction with recycling requirements, the Township will be offering the curbside leaf collection program again this fall. Bids are currently being accepted and the specific dates for the collections will be forthcoming. Please refer to the leaf collection article for more details on the program. 🌸

## Park & Recreation Summer Wrap-Up

# Stormwater & You Too!

Events in the news this summer concerning the new rules for stormwater management and their potential local impacts have highlighted the ongoing efforts of Franconia Township and the other municipal members of the Montgomery County Consortium of Communities to engage in dialogue with the Department of Environmental Resources on their MS4 (Municipal Separate Storm Sewer) Permit Program. In response to the many letters received, the department recently extended the current permit protocol and the agreed upon form of actions that the township is required to follow for a second annual extension until March 9, 2011. This program was briefly outlined in the last issue of FrancTalk. The extension is welcomed action by the PA DEP as it allows additional time for all to work through the many concerns expressed on the new rules. To the department's additional credit, they also participated at the invitation of Representative Robert Godshall, in a lively question and answer "listening" session recently hosted here at the Franconia Township Building. The department's representatives and the consortium's members were able to dialogue on the many new requirements, difficulties with their practical

implementation and associated costs, witnessed by Representative Godshall and the other state legislative representatives. Improvements to the new permit rules are expected as a result of these interactions between your representatives, both on the township, county, and state levels.

Where the "YOU TOO" comes in is the recognition that this program is not just about the organized local representatives of your township and state assembly working with the EPA and DEP to manage stormwater. It is also about how YOU TOO manage your own small part of the stormwater runoff through your own day to day activities. How you manage your property's lawn care, including fertilizers, disposal of lawn cuttings and leaves; maintenance and care of automobiles and other mechanized machinery, including collection and proper disposal of oils, grease and wash water; cleaning up and disposal of pet waste; collection of downspout runoff into rain barrels for recycling and into "rain gardens" to capture runoff for infiltration and transpiration through the enhanced root and leaf systems that such vegetation affords (that is not available in normal lawn turf grass) and of course, never placing any liquids, trash
