# Recycling is Required in Township

Franconia Township requires that residents, commercial establishments and non-residential establishments recycle all recyclable materials. Commonly recycled materials include:

- Paper newspaper, office/copy paper, glossy paper, color paper, cardboard, junk mail, phone books, cereal/cracker boxes
- Plastic bottles and jugs No. 1-7
- Glass clear, green and brown containers
- Metal aluminum, steel, tin, and bimetal cans and containers

You should check with your hauler for a complete list of accepted recyclable materials.

## Leaf Collection Bags Available At Township Building

Private municipal waste haulers operating within the Township are required to offer a curbside leaf collection to residents. As required by Ordinance #359, private municipal waste collectors must conduct the pick-up of leaf waste in accordance with the regulations of the PA Department of Environmental Protection (PADEP).

Free biodegradable leaf bags are available for Franconia Township residents at the administration building located at 671 Allentown Road from 8 a.m. to 4:30 p.m. For additional information on the leaf collection program and a list of scheduled pick-up dates please visit the Township's website.



### Interesting Facts about Glass Recycling

- Glass almost never wears out it can be recycled forever. It takes approximately one million years for a glass bottle to break down at the landfill
- Bottles and jars made from glass are 100% recyclable and can be recycled endlessly without loss of quality.
- We save over a ton of resources for every ton of glass recycled -- 1,330 pounds of sand, 433 pounds of soda ash, 433 pounds of limestone, and 151 pounds of feldspar.
- Most bottles and jars contain at least 25% recycled glass.
- In 2011, 34% of all glass containers were recycled.
- Approximately 8 out of 10 households recycle, and of those that do, 82% recycle glass bottles and jars.
- An estimated 80% of recovered glass containers are made into new glass bottles, and it can happen quickly. A glass container can go from a recycling bin to a store shelf in as little as 30 days.
- The use of recycled glass is more environmentally friendly than new. Recycling just one glass bottle saves enough energy to light a 100-watt light bulb for four hours, or power a television for 20 minutes.
- For every six tons of recycled container glass used in the manufacturing process, one ton of carbon dioxide creation is avoided.
- There are 48 glass manufacturing plants operating in 22 states. On average, a typical glass processing facility can handle 20 tons of color-sorted glass per hour.
- About 39% of beer and soft drink bottles were recovered for recycling in 2009, according to the U.S. EPA. Also recovered were about 18.1% of wine and liquor bottles as well as almost 18% of food jars. In total, 31.1% of all glass containers were recycled.

## **Traffic Signal Upgrade Coming To Intersection**

On September 21, the Board of Supervisors approved Resolution # 15-25-21-09. This was a Resolution authorizing the Township to submit an application for a traffic signal upgrade to the Pennsylvania Department of Transportation. The signal upgrade will take place at the intersection of Cowpath Road and Reliance Road. A four-way stop will be added to the intersection along with a dual flashing red light. In 2014, the Township requested a traffic study be performed at the intersection to see if improvements were warranted. The traffic study was performed and the intersection was approved for the upgrades noted above. The improvements are anticipated to be completed by the end of 2015.

#### Stormwater Ordinance Protects Environment

Any illicit discharge as defined in the Franconia Township Stormwater Ordinance is a violation of the code, and those who dump will be guilty of a misdemeanor and subject to a fine.

#### **Better Maintenance Means Better Roads for Franconia**

One of the reasons Franconia Township is such a wonderful community is its constant maintenance of Township roads. Whether it's filling potholes in the spring, paving a road in the summer or snow plowing in the winter, the Township's Public Works Department takes great pride in maintaining our roads.

The Township works closely with the Pennsylvania Department of Transportation (PennDOT) throughout the year to ensure the safety of our roadways. In fact, some of the roads within Franconia are maintained by PennDOT and some by the Township.

Currently, PennDOT has a 'turn back' program in which it encourages local municipalities to assume responsibilities for the maintenance of state-owned roadways. PennDOT will 'turn back' that state-owned road to the local municipality for maintenance, snow removal, etc. For taking over the roadway, the Township will receive additional funding from PennDOT in its annual liquid fuels allotment.

Franconia has been a part of this program since 1974. At that time, the Township took back Church Road and Fourth Street in the Telford area to rebuild the existing deteriorating roadways and to install proper drainage. in order to make traffic improvements brought on by construction of the Souderton Area High School. In 2011, Elroy Road was realigned, stop signs added, drainage installed all as a result of the program.

The most recent turn back agreement came as a part of the design and build of the Cowpath and Broad Street intersection. The Township agreed to take ownership of the new construction and all PennDOT maintained roads leading up to that project as incentive for PennDOT to allocate funding for the completion of the new intersection.

Franconia Township is now responsible for Lower Road from Allentown Road to, and including, Broad Street up to the Borough Line. We have also taken back Cowpath Road from Route 113 to, and including, Green Street to the Borough Line.

The Township Public Works Department will be working on various improvements to each of these roadways over the next 3 years. Work will start with some much needed storm drainage on Cowpath near Route 113 and a section of curbing will be completed near the Reliance Road intersection, which will include road widening and base repair in preparation for paving in 2016.

#### **Coffee With A Cop A Success**

The Franconia Township Police Department hosted its first "Coffee with a Cop" event on September 9. The event took place between 9 a.m. and 11 a.m. at the Franconia Cafe on Allentown Road. Officer Dave Klepfer greeted customers for two hours to discuss all types of police-related topics.

Coffee with a Cop is another outreach project that the police have undertaken in order to provide better communications with residents in a relaxed atmosphere. The project is one of the recommended practices that is prescribed by the U.S. Department of Justice Office of Community Oriented Policing.

The officers are available to hear concerns, discuss public safety issues and answer questions about

the law enforcement profession. Officers are also a conduit to and for the Township staff so that concerns can be addressed by the proper person or department.

Several other mornings to share a cup of coffee and a good story with your police officers are being planned.
