New Sewer Authority Executive Director

George Witmayer is the newest addition to the township staff. He was hired as the Franconia Sewer Authority Executive Director on June 20, 2005. As the Executive Director, George oversees the general planning and administrative functions of the sewer authority. He will provide assistance and guidance to devel-



opers and residents with sewer concerns or questions. He will oversee the on-lot sewer system inspections that are part of the sewer management program. In addition to these items, he

will also work closely with the township in developing the industrial district and its anticipated sewer treatment plant and industrial interceptor sewer lines.

George has an Associates Degree in engineering from Montgomery County Community College and a Bachelors Degree in Organizational Management from Eastern University. For 24 years he worked at Moyer Packing Company, in the area of environment and regulatory affairs. While there he oversaw the treatment plant operations for many years and assisted in design and construction oversight. For the last six years he has worked as a consultant, both independently, and for Penn Environmental & Remediation of Hatfield, PA. As a consultant he has assisted in the design of numerous water and wastewater projects requiring unique solutions, including metals removal, acid mine drainage, and industrial pretreatment waste.

George has been married for thirty years to his wife Jean and he has two grown children. He has lived in the general area all of his life growing up in Schwenksville and currently residing in Salford Township. The township and sewer authority are very excited and pleased to welcome George! 🌹

Police Promotions Announced

The Franconia Township Police department has announced the promotions of two patrol officers to the positions of Corporal. Edward P. Hall, a nine-year veteran of the department, and Stephen S. Rinker, who has been an officer in Franconia Township since 2002, were officially sworn-in at the monthly Township Board of Supervisors meeting on Monday, April 25, 2005.

Hall and Rinker were among seven candidates who participated in an extensive testing process that included a written examination, an oral interview panel and an evaluation of their job performance. Police Chief Joseph Kozeniewski noted that all seven were very worthy candidates but Hall and Rinker excelled in all aspects of the selection process. "We have two outstanding men for our new corporal positions," added the Chief.

Corporal Hall is an active member of the North Penn Tactical Response Team and a certified firearms instructor. He is also coordinating the department's process for acquiring accreditation from the Pennsylvania Chiefs of Police.

Corporal Rinker recently established the department's Bicycle Patrol Unit. He is also in charge of all police equipment maintenance and ordering.

They will be responsible for coordinating traffic related details, such as, addressing problem areas involving vehicle crashes and speeding violations. New Bike Patrol Unit

The Franconia Police have added a new weapon to their compliment of crime fighting and community policing tools: bicycles. The Bicycle Patrol Unit (BPU), under the direction of Corporal Steve Rinker, began pedaling on April 1, 2005. Members of the BPU include Officer Chuck Stockert, Officer Wayne Pursell, and Officer Steve Cronin. All members of the BPU have completed an intense 40-hour course offered through the International Police Mountain Bike Association and have many combined hours riding bikes, both personally and professionally.

Some of the duties of the BPU will be: patrolling Franconia's extensive park and trail systems, patrolling developments, patrolling commercial buildings, teaching kids about bike safety, and attending community events. 🌸

Single-Family Construction

Are you planning construction on your property? The Township is taking measures to increase awareness of construction impacts on our water resources. All projects that will clear, grade, or disturb a site need to install erosion and sediment controls. The sediment from construction sites must be trapped and prevented from leaving the site and getting into our storm sewer systems and creeks. Not only do our water resources need to be protected, but without these controls, properties downstream can be affected when stormwater carries the sediment down slope.

If the proper erosion control techniques are used, water quality will be improved and flooding will be reduced. Common control measures include silt fence, hydro-seeding, straw and vegetation. Please contact the Township with any questions or for more information on erosion and sediment control and stabilized measures to keep our waterways clean. 🌸

Forrest Meadow Park Partnership Program

On October 13th, 2004 Franconia Township completed and submitted a grant application for the above referenced project. In April 2005 the township was notified, by the Department of Conservation and Natural Resources (DCNR), that the Forrest Meadow Park Project was not selected for funding this year. Franconia Township still maintains a rural character and has a large amount of open space and parks and DCNR concentrated its efforts in areas that are more urban and in more need of recreational open space. The township will re-apply this year and focus strongly on our trail connections into the boroughs and our involvement in the regional plan. The application will demonstrate the positive impact the development of the park will have on the areas that are more congested and less rural than our township, mainly that it will positively affect the boroughs.

Franconia Township's Park and Recreation Committee is seeking investors to join our team to develop Forrest Meadow Park through Pennsylvania's Department of Conservation and Natural Resources (DCNR) Community Conservation Partnerships Program. The program provides state and federal grant dollars to help fund community recreation projects like Forrest Meadow Park.

The Community Conservation Partnerships Program offers a 50 percent matching

grant for the development of a park. The matching contribution from the township and its partners can be a monetary investment, non-cash "in-kind-services" donation or material donations. Monetary investments could be made on a yearly basis, once every five years or as a one-time donation. The donation of non-cash "in-kind-services" could be such things as volunteer labor, gardening, landscaping, environmental studies and other things of that nature. Material donations could be in the form of flowers, shrubs, trees, wood, picnic tables, benches, birdhouses, pavement, stone, playground equipment, recycling/trash containers and any other material that would help benefit the development of the park. Contributions can be made on behalf of a loved one with a plaque, bench, tree or even a brick.

Franconia Township has a strong park system with many beautiful acres of fields and trails for everyone to enjoy and we would like to see the park system continue to grow within the township. Strong partnerships between businesses, residents, service organizations and municipalities build stronger communities. Time to Mow

For nearly 50 years Franconia Township has regulated the appearance of all properties in the township. In order to help keep Franconia looking beautiful, it is the responsibility of residents and business owners to keep their lawns mowed. Please remember to keep grass and weeds mowed less than 12 inches high. Franconia Township's Ordinance No. 12 requires all township property owners to prevent the uncultivated growth of weeds or harmful plants and to keep ground-cover vegetation under one-foot high. Failure to comply with a township ordinance will result in a code violation notice followed by a fine or legal action. Above Ground Swimming Pool Regulations

With a new interest in "blue blow-up" aboveground swimming pools, the township would like to remind residents of our aboveground swimming pool regulations.

- 1) **All aboveground swimming pools 24" to 52" high require a building permit, which are available at the township municipal building during regular business hours.**
- 2) **Swimming pools less than 24" high (i.e., kiddie-pools) do not require a permit, but must be emptied when not in use, unless it is in a fenced-in area.**
- 3) **Aboveground swimming pools 48" and higher, with rigid sides and rims, do not require fencing.**

Since, "blue blow-up" swimming pools do not have rigid sides and rims, the township requires these and similar swimming pools to be in a fenced-in area.

Open Space Plan Approved

The township has worked very hard revising its 1995 Open Space and Environmental Resource Plan. The hard work paid off and on April 26th, 2005 the Montgomery County Open Space Board approved the plan. The approval was the first granted in Montgomery County. On July 18th, 2005 the Franconia Township Board of Supervisors officially adopted the new plan. The adopted plan will help assist the township in securing open space grant funding through the recently approved Growing Greener referendum approved in Montgomery County. The township expects to be eligible for nearly \$1.2 million in grant funding during the first round. The plan is available for review and purchase at the township building. The program is designed to increase public awareness that all stormwater systems remain free of debris, oil and other pollutants that flow into our streams.

Don't Ditch the Ditch

After it rains, stormwater runoff travels over the roads collecting debris and pollutants. The sediment, fertilizers, pet waste, oil and grease, etc. that can get into the water, quickly flow into the storm sewer where they get discharged directly into our creeks without ever being treated! The consequences of this can include odorous, unsightly algal blooms, illness from bacteria, harm to our aquatic life, and expensive laboratory testing.

Ditches, the environmentally sensitive alternative, filter out some of these pollutants and infiltrate the runoff back into our groundwater. Compared to stormwater pipe, ditches provide more capacity to convey stormwater runoff and their pervious nature slows down the velocity to allow the water to be absorbed by plants and infiltrate into the soil.

To help increase water quality and offset negative stormwater impacts, protect and preserve these low maintenance ditches! 🌿
