BOARD OF SUPERVISORS

Chairman Grey Godshall called the Regular Meeting of the Board of Supervisors to order on Monday, November 21, 2016 at 7:00 p.m. at the Municipal Building, 671 Allentown Road, Telford, Pennsylvania 18969.

Present were Chairman Grey Godshall, Vice Chairman David Fazio, Supervisor Robert Nice, Supervisor Curtis N. Kratz, and Supervisor Dr. Charles Amuso. Also in attendance were Township Manager Jon Hammer, Chief of Police Joseph Kozeniewski, Township Solicitor Eric Wert, Esquire, Township Engineer Douglas Rossino P.E, and interested residents of Franconia Township.

OPEN MEETING TO THE PUBLIC

Chairman Godshall opened the meeting to the public. Mr. Thomas Wolff, 210 Sandown Court, was present to express his concerns about the stop sign by Leidy's Church. He is requesting that someone take another look at this area and the danger of that intersection. Chairman Godshall stated that this is an issue that Mr. Hammer is currently working with the Township Engineer to identify what can be done. Mr. Rossino reported that due to the sight distance of Cherry Road and the driveway entrance of Leidy's Church, the stop sign must remain at the current location. Mr. Godshall stated that an alternative might be a three way stop and that this issue and possible solutions will be discussed at the next Board of Supervisors Work Session.

Approval of October 17th, 2016 Meeting Minutes

Supervisor Kratz made a motion to approve the minutes from the October 17th, 2016 regular meeting. Supervisor Nice seconded the motion. The motion passed.

PRESENTATION – POLICE BENEVOLENT ASSOCIATION

Officer Boyle and Officer Kranich were present to accept a donation check from JBS in the amount of \$3,000 for the shop with a cop program. Officer Boyle explained that these funds would be used to shop for families in need and will be nominated by the school district. Three families will benefit from this program, and the families will have the opportunity to shop for clothes, toys and food.

SOLICITOR'S REPORT - ERIC WERT, ESQUIRE

Mr. Wert explained that the Township's Zoning Map has been updated to reflect changes that have already been approved and taken place. Supervisor Nice made a motion to approve the revised Zoning Map, updated by Gilmore and Associates, Inc. dated September 30, 2016. Supervisor Kratz seconded the motion, the motion passed unanimously.

Mr. Wert then asked for a motion to authorize the appropriate township officials to sell the 2009 Dodge Charger to Wilcox Recycling for the amount of \$400. Supervisor Kratz made the motion, it was seconded by Supervisor Fazio. All were in favor.
