BOARD OF SUPERVISORS

Chairman Grey Godshall called the Regular Meeting of the Board of Supervisors to order on Tuesday, February 21, 2017 at 7:00 p.m. at the Municipal Building, 671 Allentown Road, Telford, Pennsylvania 18969.

Present were Chairman Grey Godshall, 2nd Vice-Chairman Robert H. Nice, Supervisor Curtis N. Kratz, and Supervisor Dr. Charles Amuso. Supervisor Fazio was absent. Also in attendance were Township Manager Jon A. Hammer, Chief of Police Joseph Kozeniewski, Township Solicitor Eric Wert, Esquire, Township Engineer Douglas C. Rossino P.E, and interested residents of Franconia Township.

OPEN MEETING TO THE PUBLIC

Chairman Godshall opened the meeting to the public.

Mr. Greg Hart from 581 Morwood Road spoke about on lot sewer inspections. Mr. Hart had concerns about the program. He recently moved into his home, with a new on lot system, and was concerned that the fee, which he feels is a tax. He feels if people are getting their systems pumped out, or people who have new systems should not be required to participate.

Mr. Jack Parry 537 Hunsicker Road questioned if this is a new program, and why this is being initiated now.

Mr. Hammer responded that the program has been around since 2004-2005 and is simply being reinvigorated at this time. A new ordinance has not been passed. Mr. Hammer stated inspections are being performed on all on lot systems because it is very difficult to ascertain if systems are working simply based on age. There are older systems that work better than newer systems.

Mr. Godshall responded that an analogy would be that all cars, whether new or old need inspection and registered each year. The goal is not to have new sand mounds all over the township, but rather to ensure the systems are working properly.

Mr. Jerry Thiel spoke on the township 537 plan. Mr. Thiel does not think President Trump's new EPA Director, Scott Pruitt will have any effect on the township's 537 plan, and recommended the township move forward. Further, Mr. Thiel stated that Penndot has plans to pave Morwood Road, we need to be conscious of their paving plans and our construction.
