Chairman Steven P. Barndt called the Regular Meeting of the Board of Supervisors of Franconia Township to order on Monday, July 18, 2011 at 7:03 p.m. at the Municipal Building, 671 Allentown Road, Franconia, Pennsylvania 18969.

A motion was made by Mr. Godshall and seconded by Mr. Freed to approve the June 13, 2011 Regular Meeting Minutes. The motion carried unanimously.

SOLICITOR'S REPORT – JOSEPH C. KUHLS, ESQUIRE

A motion was made by Mr. Barndt and seconded by Mr. Freed to table Ordinance 371 – An Ordinance Amending Chapter 145 {Zoning} Article XXVI of the Franconia Township Codebook. The motion carried unanimously.

A motion was made by Mr. Barndt and seconded by Mr. Godshall to table Ordinance 369 – An Ordinance Amending Chapter 145 {Zoning} Article XXII of the Franconia Township Codebook. The motion carried unanimously.

Dick Hendricks, Realtor and Resident at 559 4th Street asked what the remedy would be if decks and/or sheds are to close to property lines. Mr. Hendricks also spoke to the requirements listed for a Fire Separation Wall. Mr. Kuhls explained that the Board of Supervisors was taking these issues under consideration.

Roger Hope of 237 Country Club Drive, Telford and local businessman asked that the Board of Supervisors think twice about enacting the current U&O Ordinance.
