OPEN MEETING TO THE PUBLIC

Chairman Godshall opened the meeting to the public. No comments were made.

APPROVAL OF NOVEMBER 16, 2020 REGULAR MEETING MINUTES

Supervisor Amuso made a motion to approve the minutes from the November 16th, 2020 Regular Meeting. Supervisor Fazio seconded the motion. The motion passed, 4-0.

SOLICITOR 'S REPORT – ERIC WERT, ESQUIRE

Mr. Wert asked for a motion for Resolution 20-14-21-12 a resolution requiring employee contribution of 5% of all wages to the police pension plan for 2021. Chairman Godshall made the motion, it was seconded by Supervisor Fazio and all voted in favor.

Resolution 20-15-21-12 a resolution setting the real estate tax rate for the 2021 general fund budget, setting the fire service tax, setting the library tax, assessing various properties for fire hydrants and assessing properties for street lights. Manager Hammer added that as previous discussed, there are no proposed tax increases for 2021. Vice Chairman Fazio motioned for approval. Supervisor Halteman seconded the motion. Motion carried.

Solicitor Wert asked for a motion to authorize the police contract extension settlement agreement. Manager Hammer stated that the current contract is set to expire on the 31^{st} of 2020. He added that the extension would be for three more years. The one change would be

to the salaries each year. Supervisor Amuso motioned for approval and it was seconded by Supervisor Fazio. Motion carried.
