ORDINANCE # 412-21

AN ORDINANCE AMENDING THE FRANCONIA TOWNSHIP ZONING MAP TO PROVIDE THE NOD-NEIGHBORHOOD OVERLAY DISTRICT UPON MONTGOMERY COUNTY PARCELS 34-00-00443-009; 34-00-00442-001; 34-00-00445-007; 34-00-01174-034; AND 34-00-01162-001.

NOW, THEREFORE, it is hereby **ENACTED** and **ORDAINED** by the Franconia Township Board of Supervisors that the Township's Zoning Map shall be amended as follows:

SECTION 1. Amendment to Zoning.

In addition to any existing and underlying zoning classification, district, and their regulations, the real property identified as Montgomery County Parcels 34-00-00443-009; 34-00-00442-001; 34-00-00445-007; 34-00-01174-034; and 34-00-01162-001 (the "Property"), shall be further subject and entitled to the regulations of the NOD-Neighborhood Overlay District as set forth in the Franconia Township Code, Chapter 145, Zoning; and

SECTION 2. Repeal and Ratification.

All ordinances or parts of ordinances inconsistent herewith or in conflict with any of the specific terms enacted hereby, to the extent of said inconsistencies or conflicts, are hereby specifically repealed. This Ordinance shall in no other way, in and of itself, alter or modify Chapter 145 of the Franconia Township Code. Any other terms and provisions of the Chapter 145 that are unaffected by this Ordinance are hereby reaffirmed and ratified.

SECTION 3. Severability.

The provisions of this Ordinance are severable, and if any section, sentence, clause, part or provision herein shall be held illegal, invalid or unconstitutional by any Court of competent jurisdiction, such decision of the Court shall not affect or impair the remaining sections, sentences, clauses, parts or provisions of the Ordinance. It is hereby declared to be the intent of the Board that this Ordinance would have been adopted as if such illegal, invalid or unconstitutional section, sentence, clause, part or provision had not been included herein.

SECTION 4. Disclaimer.

Nothing in this Ordinance shall be construed to affect any suit or proceeding pending in any court, or any rights acquired or liability incurred, or any permit issued, or any cause or causes of action existing under the ordinances of the Township of Franconia prior to enactment of this Ordinance.

SECTION 5. Effective Date.

This Ordinance shall become effective five (5) days after enactment.


