AN ORDINANCE AMENDING CHAPTER 137 [VEHICLES AND TRAFFIC] OF THE FRANCONIA TOWNSHIP ORDINANCE TO AMEND ARTICLE IV [NO-PARKING ZONES; RESTRICTED PARKING ZONES], SECTION 137-11 [DESIGNATION OF ZONES] TO PROHIBIT PARKING OF VEHICLES ON THE SOUTH SIDE OF REGENT ROAD BETWEEN THE NORTH AND SOUTH INTERSECTIONS WITH VALLEY DRIVE.

NOW THEREFORE IT IS HEREBY ENACTED AND ORDAINED by the Franconia Township Board of Supervisors that the Franconia Township Ordinance shall be amended as follows:

SECTION 1. Amendment to Chapter 137, Article IV, Section 137-11

Chapter 137, Article IV, Section 137-11 is amended to add a new subsection 137-11.D. to prohibit parking of vehicles on the south side of Regent Road between the north and south intersections with Valley Drive. As Amended, Section 137-11 shall read as follows:

Article IV No-Parking Zones; Restricted Parking Zones

§137-11 Designation of Zones.

No-parking zones shall be as follows:

- D. The south side of Regent Road between its north and south intersections with Valley Drive is hereby designated a no-parking zone, and the parking of motor vehicles on the south side of said road is hereby prohibited.

SECTION 2. Repeal and Ratification.

All ordinances or parts of ordinances inconsistent herewith or in conflict with any of the specific terms enacted hereby, to the extent of said inconsistencies or conflicts, are hereby specifically repealed. Any other terms and provisions of the ordinances of the Township that are unaffected by this Ordinance are hereby reaffirmed and ratified.

SECTION 3. Severability.


Should any section, paragraph, sentence, clause, or phrase in this Ordinance be declared unconstitutional or invalid for any reason, the remainder of the Ordinance shall not be affected thereby and shall remain in full force and effect, and for this reason the provisions of this Ordinance shall be severable.

SECTION 4. Effective Date.

This Ordinance shall become effective five (5) days after enactment.
