Solicitor Wert announced that prior to the start of the meeting the Board met in an executive session to discuss a matter of litigation.

Chief Martin submitted the statistical report and year-to-date report prior to the meeting. He announced that the department assisted Bergey's with their 100-year anniversary event. The turnout was much larger than expected and the detour had to be pushed out a bit for the safety of pedestrians crossing everywhere. The planning continues for Fall Fest and there will be a movie night on October 11 and 12.

Resolution 24-14-16-09 A resolution granting conditional preliminary/final approval for the "Land Development Plans for Proposed Treatment Building Prepared for Godshall's Quality Meats", on the property located at 675 Mill Road, Telford, Pennsylvania. Chairman Godshall announced that this is a phasing of a previous plan to install just the building itself. Mr. Rossino added that the parking lot and stormwater management will go through a grading permit that will be required within one year of the start of construction of the building.

Supervisor Halteman motioned for approval. Supervisor Nice seconded, and all voted in

favor.
